Thank you so much for all your efforts to ensure that we are able to celebrate Women's month with women and young women across the country experiencing the greatness of the Mystic Law in their lives.

In February 2012, we will be holding Victory Introductory Meetings between the dates of Friday, February 17, and Monday, February 27. These meetings are designed to permit as many women and young women to spontaneously share with each other the faith breakthroughs they have achieved while also sharing them with their friends and family.

We strongly recommend that this year the Victory Introductory meetings be held at the group or district level to facilitate inviting friends from our communities.

Based upon the extensive feedback we have received from members all across the country, we have found that when the meetings were held at a smaller venue, many more women and young women were able to attend. Furthermore, in a smaller group, more people were able to speak up and felt comfortable freely sharing their amazing victories in faith. In addition, the closer to home the meeting is, the more likely our friends and neighbors will be to join us. As we experienced in 2011 the tremendous experiences of actual proof shared at these meetings create the ideal opportunity to introduce guests to Buddhism. Therefore, in addition to the wonderful experiences shared, an explanation of Nichiren's Buddhism can be included.

This year, please assign one woman at your meeting to take attendance and report to the next level women's leader immediately following the meeting. An attendance form is attached. We'd like to ask each level of leadership to compile the reports they receive onto one form and pass them on to the next level. (i.e. Group leader submits to District leader, District to Chapter, Chapter to Area etc.) It is not necessary to send a detailed summary of your meeting to the national headquarters as we did last February.

Note: The Victory Introductory Meeting should not replace the monthly discussion meeting.
